FINANCIAL AID ELIGIBILITY

Need-based financial assistance is available to JTS matriculated students who are U.S. or Canadian citizens. JTS students must be enrolled for a minimum of six credits in the session for which aid is requested. The six credit requirement may be achieved by taking one 6-credit course or two 3-credit courses concurrently in the same session. Eligible continuing students must have received need-based aid during the prior Fall-Spring academic year. Entering students must be accepted for programs beginning in the Summer 2020 semester. If you receive summer funding from any other sources (JTS or non-JTS), your Summer aid eligibility may be affected. Assistance is granted towards tuition and JTS housing charges only. No need-based aid is available to cover fees and/or living expenses.
